TRAILER RENTAL AGREEMENT

1. THE PARTIES: This Trailer Rental Agreement (the "Agreement") is entered into by and between Shelby Morrow (the "Lessor"), having a mailing address at 5235 Fieldgate Ridge Dr Cumming GA 30028, and _____ (the "Lessee"), with a mailing address at _____. The Lessor and Lessee, collectively referred to as the "Parties," mutually agree to abide by the terms and conditions outlined herein.

3. RENTAL PERIOD: The Lessor hereby agrees to authorize the Lessee the privilege of utilizing the Trailer throughout the duration of this Agreement, starting on _____ (the "Start date") and ending on _____ (the "End date").

6. INSURANCE: The Lessee hereby warrants to the Lessor that the Lessee possesses care Insurance that covers personal injury to Lessee or other persons as well as the Trailer and the Property of others.

7. LATE RETURN: In the event that the Trailer is returned to the Lessor after the agreed-upon End date of the Lease period, the Lessee undertakes to remit \$100.00 per day to the Lessor for each day surpassing the end of the lease period until the Trailer is returned. The Lessee acknowledges and agrees that the Lessor is authorized to deduct these amounts from the Security deposit.

8. SECURITY DEPOSIT: Upon the signing of this Agreement, the Lessee is required to submit a deposit in the amount of \$150.00, which will be retained by the Lessor as a security deposit. This deposit is intended to cover potential expenses for reasonable repairs of damages to the Trailer or to settle any outstanding amounts as per the terms of this Agreement.

9. TERMINATION OF AGREEMENT: In the event that the Lessee violates any term or condition outlined in this Agreement, the Lessor reserves the right to terminate this Agreement without the need for prior notice or understanding.

- 10. TAXES AND FEES:** ~~Throughout the duration of this Lease, the _____ agrees to covering all relevant taxes, charges, as well as license and registration fees associated with the Trailer.~~
- 11. LOSS / EXCESSIVE WEAR AND USE:** The Lessee consents to being charged for excessive wear , as determined by the Lessor's standards for normal use. Excessive wear and use of the Trailer encompass, but are not restricted to, worn tire tread, damaged glass, impaired body parts, fenders, lights, and interior damage. Any damage or loss of the Trailer exceeding the amount of the security deposit shall be the responsibility of the Lessee.
- 12. ALTERATION:** The Lessee shall not make any modifications or alterations to the Trailer without the Lessor's prior written consent. Lessee shall not alter or cover up any decals or insignia on the Trailer, or remove any operating / safety equipment.
- 13. INDEMNIFICATION:** The Lessee agrees to indemnify and absolve the Lessor from any losses and to ensure that the Trailer remains clear of fines, liens, claims, and other charges arising from the maintenance and use of the Trailer throughout the duration of this Agreement.
- 14. SUBLEASE:** The Trailer shall be exclusively utilized by the Lessee identified in this Agreement, adhering to the intended purpose of the Trailer, and it shall not be made accessible to unauthorized users or third parties.
- 15. AMENDMENTS:** The Lessee and Lessor mutually affirm that any modification to this Agreement must be in written form and necessitate the signatures of both parties. Consequently, any amendments executed by the parties will be incorporated into this Agreement.
